

Terms and Conditions

1. **HOW IT WORKS:** Beginning January 7, 2008 through April 15, 2008 (the “Fundraising Period”), you are invited to raise funds for the Children’s Cancer Research Fund (“Sponsor” or “CCRF”). You may raise the funds through any method, provided the method of raising the funds is lawful. All fundraising efforts must cease by April 1, 2008 and all eligible funds must be received by CCRF by April 10, 2007. All donations must be delivered with a completed fundraising form or through the fundraising page available at [www.ryansheckler.com] to: CCRF 11633 San Vicente Blvd. Suite 106 Los Angeles, CA 90049. All donations must be in the form of checks, money orders or credit card made out directly to CCRF. Cash will not be accepted. Any checks with non-sufficient funds are not counted as funds raised by the entrant. The entrant who raises the most funds for CCRF during the Fundraising Period in accordance with these Terms and Conditions is deemed the Grand Prize Winner. All entries and funds become the property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, incomplete, inaccurate or mutilated entries.

2. **ELIGIBILITY:** The fundraising program is open to legal individual residents of the 50 United States and the District of Columbia who are at least 13 years of age. If the entrant is a minor in his/her state of residence, such entrant must obtain permission from his/her parent/legal guardian to participate. Such permission must be evidenced by the signature of the entrant’s parent/legal guardian on the fundraising page. The program is not open to companies or corporations of any kind. Void where prohibited by law. Employees of Sponsor, its parents, affiliates and subsidiaries, participating advertising and promotion agencies and prize suppliers (and members of their immediate family and/or those living in the same of household of each such employee) are not eligible.

3. **PRIZE AND APPROXIMATE RETAIL VALUE:** One (1) Grand Prize will be awarded to the top seller from among all participating entrants. The entrant who raises the most amount of funds from among all participating entrants during the Fundraising Period will win a used 2003 Land Rover, Range Rover personally customized and used by Ryan Sheckler. If the top seller is a minor or is under the legal driving age in his/her state of residence, prize will be awarded to the top seller’s parent or legal guardian. Top seller (or parent/legal guardian if winner is under driving age) must have valid driver’s license and vehicle insurance to take possession of vehicle. Grand Prize includes round-trip coach air transportation for winner and a guest from major airport nearest winner’s residence and hotel accommodations for two people for one night (one room/double occupancy). Trip includes ground transportation to/from airport and to/from the CCRF Annual Fundraiser Event on April 27, 2008 (the “CCRF Event”). Selection of hotel accommodations, airline, airport and ground transportation at Sponsor’s discretion. Winner must travel on dates specified by Sponsor, which will be on or around April 26, 2008. If winner or travel companion is a minor, s/he must be accompanied on the trip with his/her parent/legal guardian. Travel companion (or parent/legal guardian of minor travel companion) must execute a Publicity/Liability Release prior to ticketing. Once the travel schedule has been arranged, it cannot be altered and failure of Winner to follow such schedule shall not obligate Sponsor in any way to provide the winner with alternate arrangements. All travelers must possess valid travel documents prior to departure.

Approximate retail value: \$27,000. Actual retail value depends on winner's residence. One (1) Second Prize will be awarded to the next top seller. The entrant who raises the second most amount of funds from among all participating entrants during the Fundraising Period will win Oakley sunglasses from Ryan Sheckler's signature line. 4. **PRIZE VEHICLE:** Grand Prize winner (or parent/legal guardian of minor winner), if claimed and verified, is responsible for federal, state and local taxes, licensing, registration and insurance fees and any other expenses in receipt and use of the prize vehicle. The prize vehicle will be awarded at a location determined by Sponsor. A valid driver's license and proof of insurance (of the winner or the winner's parent/legal guardian if winner is under driving age) are required in order to take delivery. Grand Prize winner (or parent/legal guardian of minor winner) agrees that neither Sponsor nor Ryan Sheckler have made nor are responsible or liable for any warranty, representation, or guarantee of any kind, express or implied, in fact or in law, without limitation, relative to the prize vehicle including, but not limited to, its quality, mechanical condition, or fitness. Grand Prize winner (or parent/legal guardian of minor winner) acknowledges that the vehicle is a used vehicle and accepts all risk associated in connection thereto.

5. **CONDITIONS OF PARTICIPATION:** Entrants (or parents/legal guardians of minor entrants) agree to be bound by these Terms and Conditions and by the decisions of Sponsor, which are final and binding on all matters pertaining to this program. The Grand Prize winner (or parent/legal guardian of minor winner) must sign and return an Affidavit of Eligibility, a Liability Release and where legally permissible a Publicity Release within 7 days following the date of first attempted notification. Failure to comply with this deadline may result in forfeiture of the prize and selection of the next entrant who raised the most funds as the winner. Return of any prize notification as undeliverable may result in disqualification and selection of the next entrant who raised the most funds as the winner. No substitution, cash equivalents, or transfer of prize is permitted except that Sponsor reserves the right to substitute prize of equal or greater value in the event that an offered prize is unavailable. Sponsor is not responsible for any typographical or other error in the printing of the offer, administration of the program or in the announcement of

6. **GOVERNING LAW:** Except where prohibited by law, all issues concerning the construction, validity and enforcement of these Official Rules, or the rights and obligations of the entrant and Sponsor, shall be construed and governed by the laws of the state of California, without regard to conflicts of law. All suits or claims brought in connection with this program must be brought in a state or federal court in Los Angeles, California.
